Mr. Bankowitz,

I am writing in regards to not hearing from you and am becoming very concerned after receiving no response to any of my daily calls or from the letters I've sent. As of today October 3rd, you have been my court appointed attorney for almost 3 months (12 weeks, 84 days) and only spoken to me 3 times:

7/14/22 Video introduction (15 mins)

8/2/22 video update (15 mins)

8/22/22 VISIT IN PERSON (90 mins)

I have written 2 letters in the meantime also, my most recent I sent on 9/12/22, with no response.

I am unaware of the difficulties you are having in communicating with me (video, phone, letter, in person), especially via phone which to me is the simplest form of doing so, even if just for a brief update which takes only minutes. I believed by you giving me your personal cell number, you were going to answer. I would at least know all is well and have a better understanding of the status of some things, what to plan on or what I may need to work on. With no

communication makes my end more difficult, drawn out and painful. Please figure out whatever necessary for my phone calls to be answered, which you will be reimbursed for when you submit your costs. It feels at this rate of communication and meetings, and you just coming onboard, not having all of my discovery to go over still on top of everything else to be done and depth, how much longer am I really going to be here added to the 32 months already? Especially if we communicate however you eventually do only 1 time a month, if that, as for all of the month of September, I know nothing from not hearing from you.

I understand you have other clients, as I am one also, and you've been recuperating from your back, but remember please how long I've been here, you are my 6th attorney (not by choice) and the magnitude of my case with not knowing what's going on or where you are, how much harder it is for me. I want to get on with my life Mr. Bankowitz and not miss anymore time necessary from my son - I've already missed 4 of his birthdays and spent 3 of my own in here. Please understand.

Know too, I am patient (clearly after all the time already invested) and still smiling and willing to go above and beyond whatever I/we need to do to properly and truthfully convey my very convoluted, misunderstood side of everything which I boldly told you in our meeting last month. I am dedicated, ready to start, overdue.

I am so very grateful Mr. Bankowitz for you, all you are doing, have done and will do. We're in this together and I'm so blessed

you are my attorney. God has put us in each others paths  
for a reason and I can't wait to see what you and He will do.  
I'm praying the 6th time's the charm.

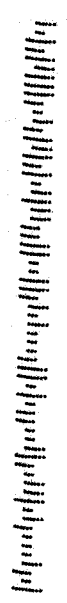
