I also received a copy of my copied letter today with only the same 2 pages included - are my letters even being read? I wrote 4 but only 2 were copied, uploaded and mailed. Clerical error?

→ An update while already contacting you:

- Mr. Bankowitz has not met with me personally (face to face) ongoing now 2 months, 8 more weeks.
- The 2 phone numbers given still do not work or his office phone answered when someone trying on the outside. \*Judge Wooten - Can you please have Mr. Bankowitz fix the phone problem? He asks me for information, some critical and time sensitive, which I complete expeditiously for him, but then have no way to relay successfully, in turn hindering progress and creating even more to discuss in a 15 minute video visit when he does actually schedule and it work. Even PD's answer their calls and I have yet to be able to speak to my court appointed attorney on 2 phone numbers for 9 months.
- July 11, 2023 is my 1 year mark (another milestone while here) with Mr. Bankowitz as my attorney - it is also my next PTC. Will I be able to attend and be included as I was previously at the last (Thank you)?
- Please also include me in the "status" hearing you mentioned to the court during the last conference which is supposed to happen some-time prior to the next PTC in July.

I am still waiting patiently and respectfully - 6,480 hours later with Mr. Bankowitz as my attorney, waiting for him to contact me and hoping just one of his phone numbers will finally work so we can pick up speed to provide significant "progress" in the upcoming meeting.

Thank you for reading my entire letter and uploading correctly for all the world to read also, critique and judge wrongly and incorrectly as usual. Ignorance is bliss.

I wonder what platform of popularity I will be featured on next and how much wasted time, effort and thought will be put into mutating and grossly exaggerating my case information rackateered to the world wide web. SMH. Run with it.

I wonder too if I have a panel of "letter readers" dedicated to all the ones I've written. Enjoy. There's more to come.

Mr. Bankowitz,

This is my 3rd letter trying to reach you over another almost 6 week period now. The same two(2) phone numbers you've given me still do not work. The one number, your personal cell, goes to voicemail directly and doesn't even ring. I've had this number since you personally gave me back in July 2022 upon your appointment as my attorney by the Court. Not working still 8 months later. The other number rings and rings and rings until it automatically disconnects me. Not working either. This also is the number you continuously tell me it just needs to be "activated." PLEASE ACTIVATE. I even in my desperation to speak with you had an outside caller try to reach you on my behalf, who tried calling your office three(3) times over the last almost 3 weeks, leaving a voicemail each time with no reply. We're both hoping you are able to reply to her email she sent today as another form of trying to communicate with you. I've exhausted my resources and am again just sitting here waiting for you to contact me in whatever way you are able and as soon as possible please. Time sensitive matters are at hand as I have made you aware of previously, verbally and in my letters.

I know you have attempted to schedule the minimum 15 minute

video calls (2) within the last week, the first having "technical difficulties" and cancelled, then the second was a NO SHOW. What it seems to be is every time on your end, whatever the "disconnect" is. I am extremely frustrated and worried not being able to communicate with you, even just sometimes, especially when there are very important, pressing discussions needing to be had already but have not from no means of successful communication.

Mr. Bankowitz, why do the phone numbers (2) still NOT WORK you've given me over 8 months ago and you keep telling me to call? NEITHER WORK and have yet to be answered.

Why are you not responding to any of my letters (3 so far this year)?

Why are you unable to correctly set up a video call, if you are even on the call? Please know, even though I am temporarily an inmate and incarcerated, I do have a schedule with classes, dorm trusty duties and medical appointments which I have to be excused from for nothing. PLEASE FIX THE CONNECTION PROBLEM.

Remember too please, I am just back to the starting line (barely) with you as my attorney and I have yet to be able to even speak to you on the phone. I am genuinely concerned with the numerous "promises" you have made, and even suggested yourself that will or can be done - but they do not (yet). I need your help and you have graciously offered to, but when? Please.

My Pre-Trial Conference I found out is now on 3/31/23 which you said previously for whatever the reason, I am unable to attend any of these conferences. How am I supposed to know WHAT'S GOING ON and what you are reporting and what is being discussed between ALL OTHER PARTIES except me - THE MAIN COMPONENT IN MY CASE, especially if we, in a still unestablished attorney/client relationship, are not in regular or proper communication with one another?

WHY CAN I NOT BE IN ATTENDANCE AND PARTICIPATE IN MY PTC? How else am I to be kept updated in "real time" and actual minutes during the conference if not there myself? I have no way of knowing ANYTHING if not updated by you, my attorney, and I do not have a computer to use/view myself?

Help me understand please - how can CourtTV, different news channels and even "professional" YouTubers attend my PTC and I cannot? How? I'm sure one of the "other" parties can help me with updates since they all will be in attendance for me also, should you be unable to provide. WHY CAN I NOT BE INCLUDED IN MY PTC FOR MY CASE? I'm sure also everything from the conference, collected from everyone else, will be vomitted all over the Internet just like EVERYTHING else has been (NON PERMISSIVELY) and can add even more dysfunction and ignorance to my pre-judgement already made by the world in the great Court of Public Opinion. I would like to be a part of all of this seeing as it ALL pertains to me. Please. It is my right.

So many questions, concerns piling and piling up from not being

able to remedy or complete from no communication. Please change, answer, fix or present. Please.

Everything you have given me to complete has been done on top of EVERYTHING else I am dealing with, keeping at bay and really trying to figure out - by myself since you are unable to, even just by answering the phone, once.

I don't know what else to say that has not already, many times. I am still here, still waiting, still hoping - 3 years later and counting. With you Mr. Bankowitz 8 months, and counting. Ready whenever you are.

Trying my best always and thanking you in advance.

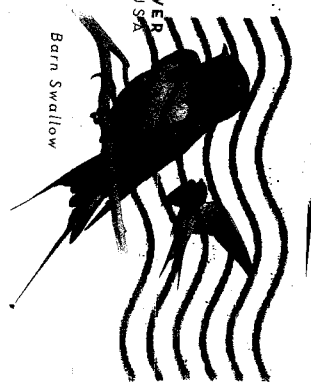

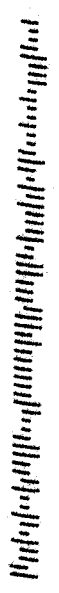
