Honorable Judge Wooten,

Forgive me in advance for having to utilize your invaluable time to ask the current "progress" of my case, but after not having any form of communication with my attorney appointed by you now after 11 weeks and counting, after sending 4 letters to my attorney appointed by you with no response, and after FINALLY finding an outside resource to inform me of the uneventful, confusing filed documents online by my attorney appointed by you, I am still waiting with the perpetual question mark over my head.

No letters, no video visits, no face to face visits, no answered phone calls from my attorney or even a response from you, your Honor, regarding one of my letters expressing my legitimate concern of WHAT'S GOING ON IN MY CASE and where's my attorney? It has now been over 4 months since being appointed ANOTHER attorney (#6) and not by my decision, influence or choice, and almost 3 of the 4 months NOT hearing from said attorney (8/22/22 last correspondence). Why? What is the reason? Why haven't I received a letter, even a 15 minute video update, anything? Even after my PTC on 10/25 is what truly confuses me and nonetheless, upsets me the fact I was not in attendance so I could know WHAT'S GOING ON IN MY CASE, especially considering I have not heard from my attorney in 11 weeks and should have been included. Why was I not - this is my case? Was Mr. Bankowitz, even there to "represent" me? I don't know... anything, still.

The problem is that my constitutional rights are incorrectly being "waived" without my knowledge or permission. I've never signed anything nor verbalized the idea I wish to "wave" my appearances to any of my court dates. I WANT TO BE PRESENT FOR ALL DATES going forward please, regardless the significance. ALL are significant to me since my attorney fails to relay any information in any way. If he's not going to, then I must myself and for myself. As always, my entire life.

What else can I do? Who else can I seek help from? I have you and God Judge Wooten. If I do have an attorney, where is he? There's so much to do ALL OVER in my case, hopefully the right way this time - off to a rocky start, where I wonder how more extended my time will be on top of the almost soon to be 36 months (3 years) already. Is this how the "justice" system really works? Am I being penalized for wanting to be fully involved in everything in my case and intelligent enough to know how my case is being handled is unjust and from my point of view, disastrous considering I'm still here sitting in Orange County jail counting the days and praying my both attorney contacts me and I/we can MOVE FORWARD, finally coming to an end ^{to} this seemingly endless debacle? You would think considering the "circus" show my entire case is being made out to be with all the hype, sensationalism and publicity (I received a letter all the way from across the pond England the other day), it would be being handled more professional, better. I learn something new every day about "facts", events and outcomes in my case from all the inmates and officers as well. I wonder if they might know where my attorney is.

Bottom line, please understand I don't want to be here any longer, I don't want to be hindered any longer in getting

just to the starting line AGAIN, I don't want to be suppressed in being heard FINALLY, truthfully and correctly. So when Judge Wooten, when will I hear from my attorney? Or you please, just with some type of response, other than a copy of my letters I keep sending which I already have?

In the meantime, it is my understanding the following documents have been filed in my case since the appointment of Frank Bankowitz, my attorney MIA:

7/11 Bankowitz appointed

7/12 PTC order - pretrial 10/25, trial 11/7

8/29 Pretrial - cancelled

9/23 Notice of Unavailability (State)

10/17 Correspondence (my letter to Bankowitz)

10/12 Correspondence to Defendant (copy of my letter)

* 10/24 NOTICE OF APPEARANCE (FOR WHAT? HAD 3 YRS AGO)

NOT Guilty Plea (ALREADY FILED)

Waiver of Appearance (NEVER SIGNED/AGREED TO)

Compensation (FOR WHAT? WHAT'S BEEN DONE?)

* 10/25 Substituting Conflict Counsel (WHO IS MY ATTORNEY?)

10/25 PTC 11/7/2023

Trial 11/30/2023

That's it? In the almost 4 months I've been a client of Mr. Bankowitz, this is the only "progress"? What's next? WHERE ARE MY COPIES of everything filed, ever? This is one way I can have some idea of what's happening and please remember, I have no access to a computer nor any reliable outside resource to check anything for me. Please mail copies. I'm trying to come up with any solution possible to keep me, the OTHER party in my case, informed and updated. This also is a part of the Court's responsibility, I would especially think knowing I've not heard from my attorney in any way for 11 weeks +. I want to be included.

As always I thank you for your time and understanding.
Please help however you are able. I am not helpless.
I am ready to get this "show" on the road and to
hear from someone other than myself asking the
same question over and over and over - What's
going on in my case? or how many more pens will
I exhaust asking?

Grateful and patiently waiting. I await your response.

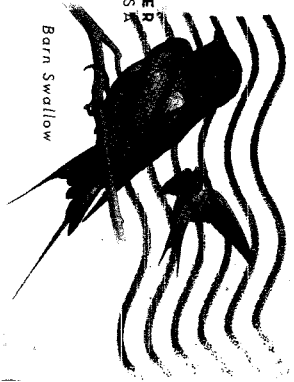
